**POLICY:**

WCB recognizes privacy of *personal information* is a fundamental social value and is committed to protecting it. WCB also recognizes the importance of transparent decision-making processes and is committed to ensuring affected parties can access relevant information.

WCB collects, uses and discloses only information necessary to administer and interpret the *Workers' Compensation Act (WCA)* and only when authorized by the *WCA*, the *Freedom of Information and Protection of Privacy Act (FOIP or the FOIP Act)* and the *Health Information Regulation*.

This policy is effective December 17, 2014, except when noted otherwise in a specific policy section(s).

**INTERPRETATION**

**1.0 Personal Information**

Personal information means personal information as defined in the *FOIP Act*. It is recorded information about an identifiable individual and, in workers' compensation matters, typically includes an individual's:

- name, home or business address, or home or business telephone number

**Personal Information  
(continued)**

- age, sex, marital status or family status
- identifying number (including a claim number), symbol or other particular assigned to the individual
- health and health-care history, including information about a physical or mental disability
- educational, financial, or employment history
- personal views or opinions (unless they are about someone else) and others' opinions of the individual
