# 2023-2025 Policy Project Plan 2023 – Q2 Update



#### Overview

WCB-Alberta's multi-year, rolling plan reflects feedback from both internal and external stakeholders. Policies are reviewed for a variety of reasons, but always with the goal of building understanding and clarity for all stakeholders. Quarterly updates are used to reflect changes in priorities, keeping the plan current. In working through the policy plan, we are committed to ensuring our policies reflect current legislation, research, and stakeholder feedback.

We use our online stakeholder consultation process to formally gather feedback from stakeholders every two years and that feedback is reflected in the rolling plan.

## **Policy Projects**

Policy projects are divided into current projects, annual updates, and completed projects. As this is a multi-year plan, status updates range from initial scoping through to expected completion dates. For example:

- Policy/issue identification project is defined and scoped; opportunities are reviewed and identified
- Information gathering this stage varies with the size and scope of the project; it includes research, data gathering, interjurisdictional scanning, and analysis. It isn't a linear process and may be done simultaneously
  - Data gathering & analysis looking internally to determine policy impacts and effectiveness
  - Research looking externally at other jurisdictions and sources of information to understand other practices and approaches
  - Academic/expert research underway for topics requiring specialized research
- **Policy drafting** draft policy is prepared for review; if the project goes ahead, most policy drafts will go through the online stakeholder consultation process
- Stakeholder consultation consultation is usually online but may include in-person/hybrid sessions
- Review of feedback feedback is analyzed and policy drafts are updated as necessary to reflect feedback
- Approval underway or complete final policy draft recommendations are brought forward for approval

Reconsiderations, Reviews, and Appeals (formerly New Evidence)	Review Policy 01-08 to ensure the intent is clear – to allow reconsiderations of previous decisions when there is valid new evidence that may change the outcome of the original decision.	Policy drafting
Permanent total disability definition review	Section 43(2) of the <i>Workers' Compensation Act</i> lists several injuries that are presumed to result in permanent total disability. We would like to engage stakeholders in defining parameters for determining additional catastrophic injuries or injury outcomes that result in permanent total disability. (Policy 04-04)	Policy drafting
Policy project planning	Use the online stakeholder consultation process to gather policy priorities from stakeholders.	Preparation for stakeholder consultation
Firefighters' primary site cancer	Develop a new application that reflects the legislative and regulatory direction for firefighters' primary site cancer.	Policy drafting
Home modifications for severely injured workers	Severely injured workers are living longer and relocating more. A review of WCB's Policy 04-07, Part II, Application 2, on home modifications is timely to ensure it is meeting the needs of stakeholders.	Data gathering & analysis
Occupational hearing loss	Review Policy 03-01, Part II, Application 5 to ensure it reflects current knowledge to provide appropriate guidance for the adjudication of hearing loss claims.	Research
